**CRIMINAL INTIMIDATION, THREAT TO LIFE, AND ABUSE OF
OFFICE AGAINST THE NATIONAL PRESIDENT OF SOUTHERN
KADUNA PEOPLES' UNITED-ASSOCIATIONS, ENGR. TABARA
SAMUEL KATO.**

1.0 Preamble/Background

I am the National President of the Southern Kaduna Peoples' United-Associations (SOKAPU), a duly registered socio-cultural organization representing the people of Southern Kaduna, committed to the promotion of their fundamental rights, security, and general well-being within the bounds of the Constitution of the Federal Republic of Nigeria, enshrined in sections 14 (2) (6) as well as Chapter IV of the 1999 Constitution of Nigeria (as amended).

SOKAPU recently instituted a fundamental rights enforcement action (Suit No: KDH/KAF/26/2026) before the High Court of Kaduna State, Kafanchan Judicial Division.

The said suit has Senator David Umahi (Honourable Minister of Works), the Attorney-General of Ebonyi State, the Commissioner of Police, Ebonyi State and Mr. Habila Tanko Wisdom, as Respondents. The action seeks judicial intervention for a transparent, independent forensic autopsy and comprehensive police investigation into the suspected unnatural and controversial death of a 26-year-old Southern Kaduna indigene and nurse, late Mary Habila, who passed away under questionable circumstances.

2.0 Subject Matter of Petition

On Tuesday, July 28, 2026, at approximately 9:39 a.m., following media interviews and the filing and service of the legal processes, my personal WhatsApp line received an incoming call from Senator David Umahi. Upon answering, the caller identified himself as Senator David Umahi, the Honourable Minister of Works. In a hostile, aggressive, and intimidating manner, he proceeded to issue direct verbal threats against my person. The Minister stated verbatim: *"I saw your suit against me, you need money right? I will teach you a lesson of your life such that you will learn never to mess with a person like me. I will give you 10 lawsuits. People are mourning and there you are taking me to court. I will deal with you!"* He thereafter abruptly terminated the call.

Again, at about 10:53 p.m. of the same day, the Minister sent yet a text message by WhatsApp, berating and further intimidating me as follows;

"Don't be afraid of the market u purchased. U will hear from legal authorities soonest. Continue another funny conference with CNN. U want 20bn naira over the unfortunate death of someone that u know nothing about. U will get 20bn different suits for a lesson of ur funny life". Attached herewith is a screenshot copy of the WhatsApp chat text message under reference.

As a law-abiding citizen and leader of a major regional body, I view this unprovoked outburst, denigration of my person and threats from a serving cabinet minister of the Federal Republic of Nigeria as a direct, grave, and malicious threat to my constitutionally guaranteed personal liberty, security, safety, and psychological well-being.

Resorting to threats, intimidation, and language such as "dealing with" an individual for exercising a constitutional right to legal redress represents a dangerous subversion of the rule of law, social justice, and democratic accountability.

3.0 Prayers

In light of the above, I urgently request the Department of State Services to:

1. Cause an immediate and thorough investigation into this explicit threat to my life and safety.
2. Hold Senator David Umahi accountable to sign an undertaking that no harm shall befall me, my family, or members of the SOKAPU executive.
3. Provide necessary security surveillance to protect my person against any arbitrary deployment of state power or clandestine aggression linked to this ongoing litigation.

Thank you for your prompt professional intervention in the interest of national security and the preservation of our constitutional democracy.
